



SAN DIEGO INTERNATIONAL DRAGON BOAT RACE 2016



PARTICIPANT WAIVER, RELEASE, AND ASSUMPTION OF RISK AGREEMENT (“Release”)

Important: Due race morning before 8:00 a.m.

This Release protects the legal and financial interests of the San Diego Dragon Boat Team, its respective board members, officers, employees, agents, and volunteers (collectively “SDDBT Parties”) involved in paddling a dragon boat, which includes but is not limited to use of SDDBT’s equipment or facilities, whether on land or on water, for the event known as the San Diego Dragon International Boat Race held on April 9th and 10th at Mission Bay Park as well as any pre- race practices, if applicable, (collectively as the “Activity”).

In consideration of the events and services of SDDBT Parties and the mutual promises contained herein, I agree to participate in the Activity and agree as follows:

1. On behalf of myself, spouse, children, parents, heirs, executors, assigns, representatives, successors, agents, insurers, and estate, I shall (1) waive all my legal and administrative rights under all applicable federal, state, or local laws and regulations; (2) release SDDBT Parties; United States Dragon Boat Federation, Mission Bay Park, City of San Diego, County of San Diego, and their respective council members, board members, officers, employees, agents and volunteers; sponsors, advertisers, and owners or lessors of premises; and all agencies/companies/individuals whose property and/or personnel are used (collectively “Other Parties”) from any and all known and unknown claims; and (3) not hold the SDDBT Parties and Other Parties responsible or liable for any and all damages that I may suffer or incurred as a result, directly or proximately, of my participation in the Activity.

2. I acknowledge that the Activity entails known, inherent and unanticipated risks that may result in serious personal, physical, or emotional injury; death; or damage to property, me, or third parties. I understand and agree that such risks simply cannot be eliminated without jeopardizing the essential qualities of the Activity. I expressly agree and promise to accept and assume all of the known and unknown risks related to the Activity. My participation in the Activity is purely voluntary, and I elect to participate in spite of the known and unknown risks. If I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately.

3. I agree that if any portion of the Release is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

4. On behalf of myself, spouse, children, parents, heirs, executors, assigns, representatives, successors, agents, insurers, and estate, I agree to indemnify, defend, and hold harmless SDDBT Parties and Other Parties against any and all claims, deductibles, self-insured retentions, demands, liabilities, judgments, awards, fines, liens, labor disputes, losses, damages, expenses, charges or costs of any kind or character, including attorney’s fees and court costs (collectively as “Claims”) which arise out of or are in anyway related to the Activity.

5. I permit the use of my name and pictures taken of me in broadcasts, telecasts, newspapers, brochures, and other forms of advertisement, marketing, or public relations materials.

6. As a participant, I certify that I am in good physical condition to participate in the Activity.

7. I also understand that the entry fee is non-refundable.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING THIS AND DO SO VOLUNTARILY, WITHOUT INDUCEMENT.
